

**FORD IT'S HER MOTION VEHICLE SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE, TEST DRIVE OR SALES PRESENTATION NECESSARY TO ENTER OR WIN.**

- 1. SWEEPSTAKES PERIOD:** The Ford It's Her Motion Vehicle Sweepstakes ("Sweepstakes") begins at 12:00 AM Central Daylight Time ("CDT") on June 11, 2024, and ends at 11:59 PM CDT on August 30, 2024 ("Sweepstakes Period").
- 2. SPONSOR:** Ford Motor Company ("Sponsor"), One American Road, Dearborn, MI 48126.
- 3. ADMINISTRATOR:** US Sweepstakes and Fulfillment Company ("Administrator"), 625 Panorama Trail, Suite 2100, Rochester, NY 14625.
- 4. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States including the District of Columbia ("U.S.") who are at least twenty-one (21) years of age, with a valid US driver's license at the time of entry. Employees, directors, officers, volunteers, independent contractors and agents of Sponsor, Administrator, UniWorld Group, Inc., GTB Agency, LLC, Essence Festivals Productions LLC, Essence Ventures, LLC, and their respective parent companies, subsidiaries and affiliates, distributors, agents and companies involved in the implementation and execution of the Sweepstakes (collectively the "Sweepstakes Entities") and their immediate families (spouses and siblings, parents and children and their spouses) and household members are not eligible. Sweepstakes is void in Puerto Rico, and other US Commonwealths, Territories and jurisdictions (including overseas military installations) and where prohibited.
- 5. AGREEMENT TO THE OFFICIAL RULES:** By participating in the Sweepstakes, each entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor, the Administrator, and/or UniWorld Group, Inc., which are final and binding in all matters related to the Sweepstakes. Winning the prize is contingent upon fulfilling all requirements set forth herein.
- 6. HOW TO ENTER:** There are two (2) ways to enter the Sweepstakes:
  - A. ONLINE** - During the Sweepstakes Period, an eligible entrant may visit <https://essence.com/ford2024> ("Website") and follow all entry instructions to complete and submit the entry form including but not limited to: first name, last name, email address, and agree to these Official Rules. Entrant will receive one (1) entry into the Sweepstakes ("Web Entry"). ALL WEB ENTRIES MUST BE RECEIVED BY 11:59 PM CDT on August 30, 2024; OR
  - B. AT EVENT** – Between 10:00 AM CDT on, July 5, 2024 and 05:00 PM CDT on July 7, 2024 an eligible entrant may visit the Ford test drive booth at the 2024 ESSENCE Festival™ in New Orleans, LA ("Event"), locate a Sponsor representative, and using the provided electronic device complete and submit the entry form including but not limited to: first name, last name, email address, and agree to these Official Rules. Entrant will receive one (1) entry into the Sweepstakes ("Event Entry"). Event Entries must be submitted no later than 5:00 PM CDT on July 7, 2024.

Event Entry and Online Entry collectively referred to herein as “Entry” or “Entries”. Regardless of entry method, all requested information must be provided. No mechanical or other reproduction of (paper) entry form permitted. Sponsor is not responsible for incorrect or inaccurate transcription of Entry information, or for any human or other error, technical malfunctions, omission, deletion, or any other error or malfunction, or late, lost, illegible, or damaged Entries. Entries are void if defective, altered, forged, illegible or obtained outside authorized channels. Entries become the property of the Sponsor and will not be returned. Entry at Event is offered on a first come-first served basis and is not guaranteed to all Event attendees; and, Sweepstakes Entities shall have no liability if a given Event attendee is present but is not provided the opportunity to enter the Sweepstakes due to time constraints or any other reason.

**Entry Limit:** Regardless of method of entry, there is a limit of one (1) Entry per person during the Sweepstakes Period. If more than one (1) Entry is received from the same person, telephone number and/or e-mail address the Entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, may not be eligible to win the prize.

In the event of a dispute, Web Entries will be deemed made by the authorized account holder of the email address submitted at the time of Entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Any potential winner may be required to show proof of being the authorized account holder to Sponsor’s satisfaction. Sweepstakes Entities are not liable for late, lost, stolen, incomplete, misdirected, technically corrupted or garbled Entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Only fully completed Entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

**7. WINNER SELECTION:** On or around September 20, 2024, UniWorld Group, Inc. (“UniWorld”), an independent representative of the Sponsor, will randomly select one (1) potential winner from among all eligible Entries received during the Sweepstakes Period. The winner is considered a potential winner pending verification of their eligibility and compliance with these Official Rules.

**8. PRIZE, APPROXIMATE RETAIL VALUE (“ARV”) AND ODDS OF WINNING:**

**A. Prize: ONE (1) PRIZE.** The prize is winner’s choice of a 2025 Explorer vehicle whose maximum ARV does not exceed \$50,000 (“Prize”). In the event that a vehicle/model is selected with an ARV of less than \$50,000, winner will NOT receive the difference in prize value. In the event that a vehicle/model is selected with an ARV greater than \$50,000, winner will be responsible for the difference. The maximum Approximate Retail Value (“ARV”) of the Prize is \$50,000.

- B. ODDS OF WINNING:** The odds of winning the Prize depend upon the total number of eligible Entries received during the Sweepstakes Period.
- C. GENERAL CONDITIONS:** There is a limit of one (1) Prize per person. In no event will more than one (1) Prize be awarded. If, for any reason, more Prize notifications are sent (or more claims are received) than the number of Prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of Prizes through a random drawing from among all eligible Prize claims received.
- D. PRIZE RESTRICTIONS:** Restrictions may apply. Winner is responsible for vehicle registration, license, title and insurance fees and for all costs associated with any available upgrade/option packages and any other expenses related to the acceptance, collection and use of the Prize not specified herein, if applicable, including but not limited to, optional equipment, freight and dealer prep, and any travel and transportation costs associated with collecting the vehicle. Sponsor reserves the right, in its sole discretion, to require the winner to select the vehicle from available dealer stock. Winner shall bear all risk of loss or damage to the vehicle after it has been delivered to the specified delivery site. All other costs not specifically stated herein are the responsibility of the winner. Winner must personally retrieve the vehicle within 30 days of written notification of delivery. Winner must have a valid U.S. driver's license and proof of insurance to take delivery. Vehicle awarded may differ from any vehicle shown in promotional materials and/or at the 2024 ESSENCE Festival™. Specific Prize vehicle details, such as color, options and equipment, will be determined by Sponsor in its sole discretion. Prize may not be transferred or assigned. No cash or other substitution may be made, except by the Sponsor, who reserves the right to substitute the Prize with another prize of comparable or greater value if the intended Prize is not available for any reason as determined by the Sponsor in its sole discretion. Winner will be responsible for all applicable taxes (not limited to federal, state, local and/or income) and will be required to provide their Social Security number or tax ID for tax reporting purposes as Sponsor will file an IRS Form 1099-MISC with the Internal Revenue Service and to the winner for the value of the Prize awarded and accepted. WI residents will not be responsible for sales tax on Prize vehicle. Sponsor reserves the right to delay vehicle delivery or substitute a similar vehicle of equal or greater value should the vehicle as described be unavailable for any reason. Except where prohibited by law, acceptance of Prize constitutes permission for Sponsor to use winner's name, hometown, likeness, statements and other personally identifiable information for promotional, advertising and marketing purposes in any media throughout the world without additional prize, incentive, consideration, consent or review; and upon request, winner will provide written consent to such use.
- 9. HOW TO CLAIM THE PRIZE:** The potential winner is subject to verification of eligibility and compliance with these Official Rules. Potential winner will be notified via email from UniWorld and will be required to sign and return, within seven (7) days of the date of the notification, an Affidavit of Eligibility, a Liability Waiver, where allowable, a Publicity Release and an IRS W-9 Form (collectively, "the Releases"). Any potential winner who does not reply to the notification with the required information

and within the specified time period or is found to be ineligible or not in compliance with these Official Rules will be disqualified and an alternate winner will be notified, time permitting, and required to sign and return the Releases.

If the Prize notification or Prize is returned as undeliverable, or if winner is found to be ineligible or not in compliance with these rules that winner will be disqualified, and the Prize may be awarded to an alternate winner in a separate random drawing from among the remaining eligible Entries, received during the Sweepstakes Period. If Sponsor is unable to determine and verify a potential winner after repeated alternate drawings or if Sponsor fails to receive a sufficient number of Entries to correspond to the number of Prizes available to be awarded, Sponsor reserves the right to not award such Prize.

**The Prize will be awarded within approximately forty-five (45) days after the winner is verified or as reasonably able based on availability of the selected vehicle.**

Sponsor will attempt to notify the potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Sweepstakes Entities shall not be held responsible for any delays in awarding the Prize for any reason.

- 10. Sponsor makes no guarantees or warranties about the Event itself. The Event Sponsor and its agents or representatives shall not be treated as Sponsor’s agents for any purpose, and Sponsor is not responsible for the action or inaction of Event Sponsor, nor is Sponsor liable for any loss or penalties incurred if Event Sponsor is sold, ceases to exist, becomes inoperative, if an Event is delayed, postponed, cancelled or changed for any reason; for acts of nature; or for amenities, services and/or facilities not being available due to renovations, strikes, bankruptcy and/or acts of nature.

**11. Entries not complying with all rules are subject to disqualification.

GOVERNING LAW/JURISDICTIONS/DISPUTE RESOLUTION:** Entrants agree that (a) any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or the awarding of the Prize shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan or the appropriate Michigan State Court located in Oakland County, Michigan; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes but in no event attorneys’ fees; and (c) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to, claim punitive, incidental and consequential damages and any other damages, other than out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE
